



RE: REAPPORTIONMENT – Update

### Dear Council:

At the recent April 2023 Council session, you adopted a recommendation to re-authorize the use of the City's previously adopted Reapportionment Plan and map from the last decennial reapportionment cycle in 2012. This was in part because while the reapportionment committee charged to develop a fully compliant map and Plan could not agree on an acceptable reapportionment Plan, it was determined that because the 2012 Plan was carefully produced and performed a functioning and in fact quite credible voter rights protocol, it served essential voting rights purposes.

Since that April meeting, it has come to our attention that as a result of some population shifts due to residential and other development on the West Side, and in order to provide for the resident population equilibrium necessary for accurate precinct voting, some re-alignment of Wards was necessary.

It is the fervent intention of officials working diligently with special consultant Dr. Peter Morrison that all appropriate and necessary steps will be taken to best fulfill the requirements to create and obtain approval of the most compliant voter rights reapportionment Plan that is possible within the time available to us.

Therefore, on Thursday night at the scheduled Special Meeting of June 29, 2023, you are going to be asked to receive this communication and any related reference materials and <u>refer</u> the matter to a committee of the whole to be set and noticed for Wednesday night, July 5, 2023 at which time all materials (to be made available as soon as possible before or at the meeting), issues and items can be reviewed, considered and acted upon. At said committee meeting, Dr. Morrison will be asked to join the meeting remotely (due to distance and cost) to assist in this process.

Thank you in advance for all considerations in this matter. I look forward to successfully obtaining Council approval to fulfill the vital aspects of our City resident and voter rights in a manner fully in conformance with best practices, with law, and in the best interests of our citizenry.



City of Danbury 2013 Benchmark Plan and 2023 Draft Final Plan (subject to Registrar's review of boundaries)



# Close-Up Detail: Wards 6 & 7





Dear President DiGilio and City Council Members:

The City Council has received the above request to modify the Agreement to Defer Increase in Tax Assessment ("Agreement") to provide for an additional extension of time of six (6) months to complete the construction of improvements at 333 Main Street until June 30, 2023. A copy of the letter submitted by Attorney Julia B. Morris, on behalf of BRT Brookview Commons, LLC ("BRT") is enclosed.

BRT requests that the Agreement be modified pursuant to Section 44-63(d)(4) of the Code of Ordinances to provide for an additional six (6) month extension until December 31, 2023 within which to complete the improvements. It is my understanding that the improvements contemplated by the Agreement are complete; however, the final certificate of occupancy cannot be issued until a Letter of Map Revision has been issued by the Federal Emergency Management Agency.

It is respectfully requested that the City Council act upon this request at the Special Meeting on June 29, 2023, as time is of the essence. The current Agreement expires on June 30, 2023.

Re: 333 Main Street, Extension of Tax Abatement Agreement

Dear Council Members:

Paragraphs 1 and 2 of the Agreement to Defer Increase in Tax Assessment dated December 29, 2022 and recorded at Book 2647 Pages 8-12 of the City of Danbury Land Records states that BRT Brookview Commons, LLC ("BRT") shall complete the construction of improvements on the above-referenced property by December 31, 2022 and that the Department of Planning & Zoning ("Department") shall certify that the improvements have been completed in accordance with the Agreement. Said paragraphs also allow for an extension of time of six months to complete the improvements to June 30, 2023 for good cause shown. The Department approved the extension request on January 3, 2023.

The Improvements as contemplated in the Agreement are complete, but the final certificate of occupancy, which such certificate demonstrates and constitutes compliance with the final site plan approval and completion of construction improvements, cannot be issued until the Federal Emergency Management Agency ("FEMA") has issued the required Letter of Map Revision ("LOMR"). The LOMR application has been submitted to the City for authorization as it is requisite to submission to FEMA. We understand now that FEMA may take up to six (6) months to review and act on said LOMR application.

As a result, BRT hereby respectfully requests City Council modify Paragraph 2 of the Agreement to indicate a one-year extension is a permissible extension to complete said

Improvements as compared to the current six-month extension. This would allow for an extension to December 31, 2023. At the time BRT requested this current Agreement, it anticipated that a six-month extension would be sufficient. However, Section 44-63 (d)(4) of the Code of Ordinances actually allows for an extension period of one year. While BRT properly estimated the time necessary to physically complete the improvements, it did not properly account for the federal agency review period. As such, it requests this modification.

Upon Council approval, BRT will file this modification of the extension period on the Danbury Land Records, which such filing shall be approved as to form and content by the Office of the Corporation Counsel. All other provisions of the recorded Agreement remain in full force and effect.
