### Meeting Minutes

The meeting opened at approximately 7:22 p.m.

Item: Approval of minutes of May 21, 2012. Motion to approve by Brian, seconded by Kim. Approved by all.

#### **Reports:**

Still River Greenway (SRG): Lin will check on the mowing.

Old Quarry Nature Center (OQNC): Jeff Hoyt has finished his Eagle Scout project at the OQNC Fieldhouse, in the rear. Lin showed the commission pictures of the project and remarked on what a great job Jeff did.

Bear Mountain Reservation (BMR): Lin reported that a male was target shooting in the parking lot area last weekend, with a BB gun. She spoke with him and he stopped. Lin also reported that someone has been dumping old tires, down at the end of the parking lot, into the woods.

#### **Old Business / Key Initiatives:**

Budget management: Lin reported that the Conservation Commission has purchased a new gas weed-eater, hedge clippers, a branch lopper and safety glasses for use at BMR and OQNC. The equipment is being stored in the shed at BMR and Shaun distributed keys for the shed lock.

#### **New Business:**
