Re: Code of Ordinances Section 12-34
Amendment by Adding subsection 12-34(b)(11)

Dear Mayor and Council:

City ordinance section 12-34 (b) (1) through (10) contains a listing identifying the ordinance sections and officials permitted to issue warnings and citations for identified violations of local law. Over time and as the City adopted new ordinances allowing enforcement by citation, this section has expanded accordingly. In an effort to limit that expansion, but yet to allow new and future ordinances you adopt to provide for continued use of the citation remedy, we are proposing the adoption of a "catch-all" provision as attached. It is fairly self evident, in that (b) (11) will allow the automatic inclusion of warning and citation authority for those officials identified in any specific (new) future ordinance that provides for such remedy. Therefore, and from now on, only the underlying ordinance has to be adopted, without the need to repeatedly amend Section 12-34, as we have had to do in the past.

Please consider the attached language in the usual fashion, and do not hesitate to call me if you have any questions.

ORDINANCE

CITY OF DANBURY, STATE OF CONNECTICUT

COMMON COUNCIL

Be it ordained by the Common Council of the City of Danbury:

THAT Subsection 12-34(b) of the Code of Ordinances of Danbury, Connecticut, is hereby amended by adding paragraph (11) which said paragraph shall read as follows:

Sec. 12-34. Citations

(b)(11) In addition to those officials and those provisions of the ordinances of the City of Danbury already referenced in (b)(1) through (b)(10), officers and employees designated pursuant to the provisions of any other duly enacted ordinance providing for enforcement by citation procedure are hereby so authorized.

| COPY SHOWING DELECTION AND NEW LANGUAGE:

THAT Subsection 12-34(b) of the Code of Ordinances of Danbury, Connecticut is hereby amended by adding paragraph (11), which said paragraph reads as follows:

Sec. 12-34. Citations.

(B)(11) IN ADDITION TO THOSE OFFICIALS AND THOSE PROVISIONS OF THE ORDINANCES OF THE CITY OF DANBURY ALREADY REFERENCED IN (B)(1) THROUGH (B)(10), OFFICERS AND EMPLOYEES DESIGNATED PURSUANT TO THE PROVISIONS OF ANY OTHER DULY ENACTED ORDINANCE PROVIDING FOR ENFORCEMENT BY CITATION PROCEDURE ARE HEREBY SO AUTHORIZED.
