
We have been contacted by a number of constituents from the 6<sup>th</sup> Ward regarding noisy motorcycles and ATVs traversing the undeveloped portion of Briar Ridge Rd. (reference attached map). The complaints state that these "joy riders" use this area as a cut through, often during late hours of the night which disrupts the peace and quiet in the neighborhood. They further indicated that attempts to address the problem through police enforcement have been unfruitful because the offending parties leave the area before police can reasonably respond.

We inspected the Briar Ridge Rd. area in question, and observed evidence of the type of vehicular traffic mentioned above. In addition to the traffic, we noted that the area is being used as a dumping ground for things such as motorcycle parts, an oil drum and yard debris. We believe this illegal dumping, while unsightly, also creates a public health hazard.

Some of the residents of this area have requested that the City erect some sort of physical barrier at each end of the undeveloped portion of Briar Ridge Rd. to prevent traffic from traversing the area, a proposal with which we agree. In addition to physical barriers, we believe the City should post the area forbidding dumping and motor vehicle traffic.

We are requesting that the Common Council refer these issues to an ad hoc committee to seek resolutions to both the problems of noisy, after hours traffic and the illegal dumping.


