At the August 3rd, 2004 Common Council meeting I was assigned Chairman of the Ad Hoc Committee for Item #19, renaming one of the two Shepard Roads in Danbury to Shepard Road Ext. This past weekend a constituent expressed her concern to me about the delay in an ambulance response to her home on Sunset Drive (Snug Harbor) possibly due to the confusion that there is another Sunset Drive near Southern Blvd.

After doing some research, the Fire Department Communications Supervisor Patrick Sniffin provided me with the enclosed list that shows Danbury has twenty-seven streets that share the same name with another. In an emergency, today more than ever we realize that every second counts, and it is imperative that our Police, Fire, and Emergency Medical Services receive clear and precise street information while being dispatched. It could be a matter of life or death.

I am therefore respectfully requesting that you will see fit to appoint an Ad Hoc Committee to study this issue at the September 7, 2004 Common Council meeting.
