Dear Joe:

On July 7, 2004, the Common Council approved an extension of a sanitary sewer main to service Candlewood Park. On December 6, 2005, the Common Council approved the extension of a water line to service Candlewood Park as well. On May 2, 2006, the Common Council extended the time of the approvals to December 1, 2006.

The project was delayed subsequent to that date in order to determine that the lines could be laid in McKay Road which is a city road that has not been discontinued but whose use has been abandoned for a number of years. We have provided all of the information to the City to allow the project to move forward along that route but in the interim the approvals have expired. The Petitioner has applied for permits to commence the work but needs to request that the time period set forth in the initial approvals be extended to allow the work to go forward.

I would appreciate it if you would refer this matter to the appropriate subcommittee, or in the alternative, arrange to place this matter on the consent calendar for the purpose of extending the time periods as requested.

I thank you in advance for your anticipated cooperation in this matter.
