Dear Vin:

I am petitioning the Common Council of the City of Danbury for permission to extend a municipal water line from the entrance of the Sterling Woods Condominium on Nabby Road (Nabby and Palmer Road) along McKay Road to the perimeter of the mobile home park known as Candlewood Park, Inc. The purpose of the extension of the line is for back up emergency water service to the park in the event of a failure of the current public water supply system which services the park from privately owned wells. I am enclosing herewith a set of drawings prepared by R.J. Gallagher, Jr. and Associates which shows the route of the proposed water line running adjacent to the recently approved sewer extension.

I would appreciate it if you would put this matter down on an agenda for the Common Council to refer it to the appropriate subcommittee and to advise us of when the subcommittee has been appointed and when it will meet.

I thank you in advance for your anticipated cooperation in this matter.
