Boughton, Mayor of the City of Danbury, is hereby authorized to approve and submit the City's Consolidated Plan 2005-2010 and Annual Action Plan for PY33 and make application on behalf of the City of Danbury to the United States Department of Housing and Urban Development for grant funds for the Community Development Program Year commencing August 1, 2007 through July 31, 2008 for the Thirty-Third Year Funding in accordance with all pertinent laws and regulations and the Statement of Community Development Objectives and Projected Use of Funds proposed by the Mayor's Community Development Program Policy Committee.
